Programme outline

The Technology, Media and Telecommunications Law (TMT) specialism is an innovative postgraduate programme offering students the opportunity to develop academic and professional expertise in this specialised area of law.

The programme of study provides a flexible mix of classroom-based teaching (assessed by formal examinations or coursework) for taught modules, online learning as well as a compulsory research component.

One of the distinctive features of the LLM Paris is the exceptionally wide range of modules offered and the flexible structure designed to enable students with work or study commitments to complete the programme on a part time basis without having to interrupt their professional career. This specialism will complement and add to the existing range of modules on the LLM Paris.

Aims of the programme

The programme will enable students to develop a detailed, critical and advanced knowledge of key areas in the specialism to prepare them for a career in the field of IT law or to help them further their existing career. The programme also seeks to broaden and deepen students' understanding of their own legal systems by giving them the opportunity and the tools with which to explore current commercial law issues from an international and comparative perspective. Ultimately, the programme aims to better prepare contemporary lawyers for practising the legal profession in an increasingly globalised world.

Programme Title: Technology, Media and Telecommunications Law (Paris) and interactive lectures, small group teaching, seminar sessions and e-learning. You will also be expected to invest a significant amount of time on independent learning including reading materials in advance of lectures/seminars, preparing class presentations or doing assignments. You will also have to carry out research to complete your dissertation. For this purpose you will have access to a variety of legal resources and you will receive training on how to use them for your dissertation. How will you be assessed? A variety of assessment strategies will be used. Taught modules are usually assessed by unseen written examinations, but in certain cases other assessment methods may be used, such as in class presentations, take home assignments, a combination of short essays and written examination or assessment entirely based on course essays. The Distance Learning modules will be assessed by short tasks, course essays and 24 hour take home exam style questions. This is in addition to the compulsory requirement to write a dissertation. How is the programme structured? Please specify the full time and part time programme diets (if applicable). The description should be sufficiently detailed to fully define the structure of the diet. The LLM requires students to successfully complete 180 credits by obtaining credits through a combination of: 1. Taught TMT modules in Paris (15 or 30 credits) 2. Online TMT modules (15 credits) 3. Taught modules in Paris (non TMT) (22.5 credits) 4. Compulsory dissertation (45 credits) 5. Research seminar (15 credits) Students must take at least 90 credits of TMT modules and also write their dissertation in this area to achieve the specialism. They will not be able to take modules containing similar content both in Paris and by DL. By preference we would suggest they follow the Paris TMT modules rather than the equivalent DL module but in certain cases the DL module may be more appropriate for a student. (Distance Learning Modules are run on a two year cycle - please check module availability)

What are the entry requirements?

The usual admissions criteria for the law postgraduate programmes apply.

i.e. a degree in law, or a degree with substantial law content, normally of at least Upper Second Class Honours (or equivalent) - 12/20 in the French licence. The following also qualify for entry to the LLM: a non-law graduate with good Honours who has obtained the equivalent of First Class or Second Class Honours in CPE and Bar Finals/Legal Practice examinations, or passed the solicitors' qualifying examination. In exceptional cases persons not meeting the normal entry requirement may be considered if they have sufficient relevant experience.

- Evidence of English language proficiency will also be required, equivalent to 7.0 overall in an IELTS test with a minimum of 7.0 in writing.
- In order to judge the ability of applicants, emphasis is placed on references.
- Applicants are also required to provide a transcript of their marks (with an official (though not necessarily through a notaire) translation if not in English) from their former college or university.

How do we listen to and act on your feedback?

The Staff-Student Liaison Committee provides a formal means of communication and discussion between schools/institutes and its students. The committee consists of student representatives from each year in the school/institute together with appropriate representation from staff within the school/institute. It is designed to respond to the needs of students, as well as act as a forum for discussing programme and module developments. Staff-Student Liaison Committees meet regularly throughout the year.

Each school/institute operates a Learning and Teaching Committee, or equivalent, which advises the School/Institute Director of Taught Programmes on all matters relating to the delivery of taught programmes at school level including monitoring the application of relevant QM policies and reviewing all proposals for module and programme approval and amendment before submission to Taught Programmes Board. Student views are incorporated in the committee's work in a number of ways, such as through student membership, or consideration of student surveys.

All schools/institutes operate an Annual Programme Review of their taught undergraduate and postgraduate provision. APR is a continuous process of reflection and action planning which is owned by those responsible for programme delivery; the main document of reference for this process is the Taught Programmes Action Plan (TPAP) which is the summary of the school/institute's work throughout the year to monitor academic standards and to improve the student experience. Students' views are considered in this process through analysis of the NSS and module evaluations.

What academic support is available?

The Programme Director will provide academic support to students and will be available to address any academic needs on an individual basis.

In addition, the following academic support mechanisms include:

- All module convenors have office hours whereby student students can contact them remotely
- An individual Dissertation Supervisor who is allocated for each student
- A Dissertation workshop
- The Critical Thinking and Writing in Law Programme has designed a series of tailor-made hands-on workshops that allow students to deepen their understanding of the learning strategies required of postgraduate study, and which will help them improve their research and writing skills, and provide them with the confidence necessary to succeed in their LLM.

Programme-specific rules and facts

The LLM Paris is governed by QM general academic regulations and LLM specific regulations. Overall the programme is modelled
on the LLM (London) regulations but adapted to specific Paris circumstances in areas such as attendance.

Specific support for disabled students

Queen Mary has a central Disability and Dyslexia Service (DDS) that offers support for all students with disabilities, specific learning difficulties and mental health issues. The DDS supports all Queen Mary students: full-time, part-time, undergraduate, postgraduate, UK and international at all campuses and all sites.
