# **Application process**

- Formulate a provisional research proposal to be assessed by the School. For guidelines and further information see 'preparing a research proposal' page: busman.qmul.ac.uk/ postgraduate/phdprogramme/proposal
- Send a copy of your proposal and CV to academics whose research area matches your research topic. You can find a list of our staff here: busman.qmul.ac.uk/staff/academic
- Submit a formal online application here: qmul.ac.uk/postgraduate/research/subjects/ business-and-management
- If the entry requirements are met, your application will be sent to your selected and/ or other potential supervisors.
- 5. Any interested supervisors will then arrange an interview. This will be in a panel format probably over Skype.
- 6. If successful from interviews you will be offered a place.

# **Entry requirements**

- Bachelor's degree with 1st class honours (or international equivalent)
- MA, MSc or MRes at distinction level in Business, Management or a discipline related to your research topic
- IELTS 7.0 overall with minimum of 6.5 in writing if English is not your first language.

#### Application deadlines September 2024 entry

- HSS Principal Studentships: 24th January
- China Scholarship Council: 31st January
- Self-funders can inquire with prospective supervisors throughout the year.
