Apply for your Student immigration permission outside the UK

This guide is for Queen Mary University of London students who are applying for a Student Visa from outside the UK to come to study in the UK at Queen Mary University of London.

In summary, you will need to complete the Student Visa application form and pay the visa application fee and Immigration Health Surcharge (IHS) online.

The date you pay the IHS charge and application fee is the date you have made your visa application. Please ensure that your documents (if applicable) meet the Student visa requirements on this date.

Before you apply for your student visa, you should check that you meet all the requirements, and you have all the relevant documents for your visa application.

Every applicant for a Student Visa will need to have been issued with a Confirmation of Acceptance for Studies by Queen Mary University of London for your course of study, and you will need your valid passport or travel document.

For some Student Visa applications, you will need to check if you need to provide:

- <u>ATAS clearance</u> required for some course
- <u>TB Clearance Certificate</u> required for some applications from listed countries
- Evidence of qualifications listed on your CAS for some applicants
- <u>Evidence of your finances</u> for some applicants
- <u>Any other evidence</u> relevant to your application for some applicants

EU, EEA, and Swiss Citizens:

The next question you will see asks if you have an EU, EEA, or Swiss passport. If you are not an EU, EEA or Swiss citizen answer "No" to this question and move on to the next stage of the application.

This is because there is a different way of applying for the student visa available to EU, EEA and Swiss citizens. To confirm your identity, you can use the free **UK Immigration: ID Check app** to scan your passport with a biometric chip and upload a photo of yourself.

Note: EU, EEA, and Swiss citizens who are able to use the UK Immigration: ID Check app, will not need to visit a Visa Application Centre as part of the Student Visa application. Additionally, your Student Visa permission will be digital only and you will not be issued with a visa vignette to enter the UK nor a Biometric Residence Permit as evidence of your permission to study in the UK.

EU, EEA, and Swiss citizens will be issued with an email confirming when a Student Visa has beengranted. The way to demonstrate your student visa will be online through the UK government website https://www.gov.uk/view-prove-immigration-status

All other citizens applying for a Student Visa:

All other nationals (and those EU, EEA and Swiss citizens who are unable to use the UK Immigration: ID Check app) will need to apply online, attend an appointment at the Visa Application Centre to prove identity, submit their passport to the Visa Application Centre and will be issued with an Entry Clearance Visa (vignette or sticker in your passport) to enter the UK and a Biometric Residence Permit in the UK if the Student Visa permission is longer than 6 months.

Language of the Visa Application Form:

You can choose the language of the questions in the visa application form. We suggest that you choose English.

Unless you are an EU, EEA or Swiss citizen applying using the UK Immigration: ID check app, you will need to book an appointment to provide your biometrics at a Visa Application Centre.

You should choose the country in which you are living (if you are in a country that is not your home country, you may be able to attend a Visa Application Centre if you are resident for example due to studies, but not if you are there as a visitor).

5. Personal Details Section

Your name:

Please complete the details as your name is spelt on your passport.

If you have any other names, you will be asked to complete further questions. You should copy the the tails as they are spelt on any official documents.

You should also provide details of any other names that you are known or have been known by including any different spelling that you have used for your name(s).

Your Gender and relationship status:

For gender select one of the options: Male, female or unspecified.

For relationship status, choose one of the options in the drop-down selection.

Your Address:

This will normally be your normal residence in your home country or where you are currently living and should be the address where you can receive correspondence about your application.

If you cannot receive correspondence at your address, you can provide an alternative address where you can receive correspondence in this section of the application form.

About this property:

You are asked how long you have lived there. If you are not completely sure, you should choose the number of years or months that is closest to what you believe.

You are also asked the status of the property where you live: if you own or rent the property or the status is other.

If, for example, you live in your parents or other family members home, you can choose "Other" and in the free text box that appear, you can explain in one sentence that you live with that family member who owns or rents the property themselves.

Other addresses in the past two years:

If you have been living at your address for less than 2 years, you will be asked to complete the questions with details of all the other addresses that you have lived at in the past 2 years. These should be places you genuinely resided in for living/study/work etc.

Your Passport:

Enter the passport details of your current, valid passport that you intend to submit with your immigration application. This should match the passport number in your CAS statement. If it does not match, please contact cas-admissions@qmul.ac.uk before proceeding with your immigration application.

Note: As long as your passport is valid at the time of your application and intended travel date to the UK, there is no minimum period of validity required for your passport.

Identity card:

If you have a national identity card (an official identity document issued by your country), please complete the details in this section. This includes identity cards, issued from non-UK governments. This does not include driving licences. If you have an internal passport, provide the details here.

If you do not have a national identity card, you can answer "no" and move to the next section.

Your nationality, country and date of birth:

Enter your country of nationality or citizenship as shown on your passport.

If you have more than one nationality and more than one passport, you may wish to consider which nationality and passport it would be advantageous to apply with (for example applying under the differentiation arrangements is possible).

You will still need to provide details of all your nationalities in your visa application and you must inform the International Admissions team of your nationalities.

Other nationalities:

If you have previously or still hold another nationality, then select 'yes' and complete the following details. If you have not, please select 'No' and continue.

Applying for a Student Visa in a country not of your nationality:

You normally need to apply for your student visa in the country of your residence. This will normally be the country of your nationality. However, in some cases if you are a temporary resident (e.g.: on astudent visa) or a permanent resident in another country, you can apply there.

If you are in another country of which you are not a national as a visitor or a tourist, you cannot normally apply from there and must return to your country of normal residence to apply for your Student visa.

6. English Language Section

Nationals of Majority English Speaking Countries:

If you are a national of a majority English speaking country (e.g.: Australia, Barbados, Canada, JamaicaNew Zealand or USA and a few others), your Student Visa application form should not ask you questions about your English language ability and you will be directed to the next section of the Student Visa application form.

You can find a current list of majority English speaking country nationalities on the UK Government website <u>https://www.gov.uk/student-visa/knowledge-of-english</u>

Nationals not considered Majority English Speaking Countries

Most other QMUL students (nationals of countries which are not majority English speaking) applying for a Student Visa for a course at degree level or above, will be able to prove their English language ability either through having previously met the English Language requirements in a previous visa application or because QMUL, as a Higher Education Provider with a Track Record of Compliance, has stated on your CAS that the institution has assessed your English language and you meet the minimum B2 requirements in all four components.

Some other students, mainly those studying at below degree level, may have to prove English language ability through one of the other possible options

a. Evidence of English Language Ability provided in a previous visa application

Have you provided evidence of your English language ability in a previous application?

You must have provided evidence that you either:

- scored level B1, B2, C1 or C2 on an approved English language test which assessed your reading, writing, speaking and listening skills
- have a degree which was taught in English
- have an English GCSE, A level or Scottish National 4 or 5, Higher, or Advanced Higher qualification



You can check your CAS to see how your English language ability was assessed.

If your CAS says that your English language has been assessed in another way, select **NO** and answer the following questions according to your situation.

You should only answer "Yes" here if you have previously provided evidence of your English language ability at the required level in a previous UK visa application.

If you answer "Yes" here, you will not be asked any further questions about English language and will be taken to the next section of the application form.

b. Spoken language preference:

This is in case UKVI need to speak to you about your application. You can either select English or Other. It would be advisable to choose English.

c. English Qualification from an English School

In most cases, QMUL students studying at degree level or above will not need to provide evidence of their English language as your CAS should state that QMUL has assessed your English language ability.

However, in case QMUL has not made its own assessment if you have an English language or literature qualification from a UK school you attended when you were under 18, you can provide your exam certificate. You can use a GCSE, A level, National 4 or 5, Higher, or Advanced Higher qualification.

If you answer "Yes" here, you will not be asked any further questions about English language and will be taken to the next section of the application form.

d. English Language Assessment

In most cases, QMUL students studying at degree level or above will not need to provide evidence of their English language as your CAS should state that QMUL has assessed your English language ability.

If this is the case as stated on your CAS, you can answer "Yes" to the question "Are you coming to the UK to study at a higher education provider with a track record of compliance?"

In the follow up question "Does your Confirmation of Acceptance for Studies (CAS) statement indicate that your English language ability was assessed by your institution or that you are a 'gifted' student?

If you answer "Yes" to both questions here, you will not be asked any further questions about English language and will be taken to the next section of the application form.

e. Short Term Study

In most cases, QMUL students studying at degree level or above will not need to provide evidence of their English language as your CAS should state that QMUL has assessed your English language ability.

You should only answer "Yes" here if you are attending a short-term study abroad programme at QMUL as part of a university course you are attending in the USA.

If you answer "Yes" here, you will not be asked any further questions about English language and will be taken to the next section of the application form.

f. Studying English as a Foreign Language

In most cases, QMUL students studying at degree level or above will not need to provide evidence of their English language as your CAS should state that QMUL has assessed your English language ability.

Unless you are studying English as a Foreign Language (not pre-sessional English), you can answer "No" to this question if it appears in the application form.

g. Degree Taught in English

In most cases, QMUL students studying at degree level or above will not need to provide evidence of their English language as your CAS should state that QMUL has assessed your English language ability.

However, in case QMUL has not made its own assessment and you have a degree taught in English, you may be able to rely on your degree taught in English as evidence of your English language ability.

h. English Language Test

In most cases, QMUL students studying at degree level or above will not need to provide evidence of their English language as your CAS should state that QMUL has assessed your English language ability.

However, in case QMUL has not made its own assessment (for example because you will be studying below degree level) and you have passed an approved English Language Test in the last 2 years, you may be able to rely on your English Language Test as evidence of your English language ability.

i. English Language Test Exemption

In most cases, QMUL students studying at degree level or above will not need to provide evidence of their English language as your CAS should state that QMUL has assessed your English language ability.

However, in case QMUL has not made its own assessment of your English language ability, if you believe that you are exempt because a medical condition prevents you from taking a test, you will need to provide a letter from your doctor confirming this.

7. Your Family Section

People financially dependent on you:

If you are bringing children or relatives who are financially dependent on you to the UK or if they are remaining in your home country, then you should answer 'yes'. If you do not have anyone who is financially dependent on you then you can select 'no.'

A financial dependant is anyone who relies on you financially for things like money, clothes, or food. This might include children, spouses, or other relatives.

If you select 'Yes' you will be asked to complete questions about the people financially dependent on you.

Give details about your parents:

You will be asked to provide details of your first parent. It does not matter which parent you choose. Please complete their details as they would appear on their passport or travel document.

You will then be asked to complete the details of your second parent.

If you do not have their details, you can select 'What if I do not have my parents' details?'

Family in the UK:

If you have any family that live in the UK, you can select 'Yes' otherwise you can select 'No'. If you answer 'Yes' you will be asked further details about your relative.

You will also be asked to provide their passport number and information about their status in the UK if they are not a British or Irish citizen such as whether they are permanent residents in the UK or have a temporary visa.

If you have more than one relative living in the UK, you can then add information about additional relatives.

8. Travel and Residence in the UK section

Travelling as part of an organised group:

If you will be coming to the UK as part of an organised group which includes travel companies, sports, work, or study groups you should select 'Yes.' You will then be asked for the name of thecompany or group name.

If you will be travelling on your own or with a friend or family members you should select 'No.'

Travelling with another person:

If you are travelling with someone who is not a dependant, spouse, or partner (e.g. with a parent or afriend) select 'Yes' and complete their details as requested.

Otherwise please select 'No'

Staying in the UK with family:

If you answered yes to the question about family members in the UK, you will be asked if you plan to stay with your family members.

If you will be staying with (one of) your family members in the UK, you can select the family member you have provided details for in answer to this question.

If you will not be staying with your family member in the UK, you can click on "save and continue" without selecting the family member, you have provided details for in your application

form. If you do not have any family members in the UK, you will not be asked this question.

Where will you stay in the UK:

If you have already arranged your accommodation, select 'Yes' and complete the details of the address of the accommodation.

If you have not yet arranged your accommodation, you can select 'No' and you will be prompted to give details about where you will be staying (your accommodation plans in the UK).

You could write something like "not yet confirmed" or "to be confirmed once my visa is granted." If you plan to stay in private accommodation, you can write: 'private accommodation.' If you will be staying in QMUL accommodation, you can write: 'University halls of residence.

When you have arranged your accommodation, you should let the Home Office know that your details have changed. You can do this online: <u>http://www.gov.uk/change-circumstances-visa-brp</u>

Other places you will stay while in the UK: Answer honestly based on your situation. For example, ifyou are staying in a hotel or with a friend when you first arrive in the UK before moving into your accommodation, you can answer 'Yes' and you will be asked for further details of where you will stay.

If, as far as you know, you will not be staying any other places you can answer 'No'

UK Travel history:

If you have not been to the UK in the last 10 years you can select 'No'

If you have been to the UK please select 'Yes' you will then be asked details of how many times you visited and you will be asked details about the purpose of your visit and the length of your stay of your 3 most recent times that you have been in the UK.

Depending on how you answer this question, some of the following questions may or may not appear in your student visa application.

Medical Treatment in the UK

This question will only appear if you have stated that you have previously travelled to the UK.

If you have ever received medical treatment in the UK (including for example, if you visited a doctor, clinic or hospital, this counts as having medical treatment), you should answer "yes" here and provide the additional details requested.

If you have never received any medical treatment in the UK at all, you can answer "no" here.

UK Visa applications

This question will only appear if you have stated that you have never travelled to the UK.

If you have not been issued a visa for the UK in the past 10 years you can select 'No'.

If you have been issued a visa for the UK, then please select 'Yes' and complete the following details.

Leave to remain in the UK:

This question will only appear if you have stated that you have previously travelled to the UK.

If you have not been issued a visa extension for leave to remain the UK in the past 10 years you can select 'No'

If you have applied for leave to remain in the UK, then please select 'Yes' and complete the following details.

National Insurance Number:

This question will only appear if you have stated that you have previously travelled to the UK.

Answer Yes or No if you have a UK National Insurance number.

If you answer yes because you have a UK National Insurance number, you will be asked to provide the National Insurance number.

UK Driving Licence:

This question will only appear if you have stated that you have previously travelled to the UK.

Answer Yes or No if you have a UK driving licence.

If you answer yes because you have a UK driving licence, you will be asked to provide the driving licence number.

Finance – UK Public Funds:

This question will only appear if you have stated that you have previously travelled to the UK.

Answer Yes or No if you have ever received UK public funds (government benefits).

If you answer yes because you have received UK public funds, you will be asked to provide details of the public funds you received.

Travel to Australia, Canada, New Zealand, USA, Switzerland or the European Economic Area:

Answer yes if you have ever travelled to any of these countries (Australia, Canada, New Zealand, USA or a European Economic Area member state) complete the details.

If you have visited these countries in the past 10 years you will be asked to provide information about your visits.

If you have not, then you can select 'No'.

You will be able to provide details of more than one visit. However, if the application form does not allow you to enter all your previous trips to these countries, you can provide details in the Additional Information section at the end of the application form.

World travel history:

If you have not visited any other countries (apart from the UK, Australia, Canada, New Zealand, USA or a European Economic Area member state) in the past 10 years then you can select 'No'

If you have and you select 'Yes', then you will be asked for details about your trips.

You will be able to provide details of more than one visit. However, if the application form does not allow you to enter all your previous trips to these countries, you can provide details in the Additional Information section at the end of the application form.

If you are undertaking a course which is at least six months long - or a pre-sessional course, you will be allowed to travel to the UK up to one month before the date in the "Course start date" field in your CAS statement, or one week before your intended travel date, whichever is later.

If you are coming to the UK for 6 months or longer, you will be issued with an Entry Clearance vignette (sticker) in your passport which is valid for 90 days. You must enter the UK before the end of this 90-day period.

(EU, EEA and Swiss citizens who apply using the UK Immigration: ID check app won't be issued with an Entry Clearance vignette but instead will be issued a digital status and an email confirming grant of your student visa with valid from and valid to dates.

The 90 days will start from one week before the date you intend to travel to the UK or one month before the start date of your course as stated on your CAS, whichever is later.

If you do not travel to the UK during this 90-day period your entry clearance will expire and you will need to apply for a replacement entry clearance (visa transfer) if you still wish to travel to the UK.

If your course is less than six months and is not a pre-sessional course, then you will be allowed to travel to the UK up to 7 days before the date in the "Course start date" field in your CAS statement.

18. BRP (Biometric Residence Permit) collection

The final section before payment is regarding BRP collection. This will be your actual permission to stay in the UK for study (if your visa is longer than 6 months).

You must collect it from a Post Office within 10 days of arriving in the UK or before your entry clearance visa to the UK expires.

You are only eligible for a BRP if your visa will be longer than six months. If your visa is for less than 6 months, you will receive a vignette (sticker) in your passport for the full length of your visa.

Please note that you should choose to collect your BRP from a Post Office and not from an Alternative Collection Location as this is not available currently.

Check <u>our guidance</u> for a map of the nearest participating Post Office to the campus where you will be studying and the relevant postcodes to write on your application form.

Note: If you are an EU, EEA or Swiss citizen who applied for your student visa using the UK Immigration: ID check app, you will not be issued with a BRP and your status will be digital only.

A standard student visa application should normally be considered within 3 weeks of submission of application.

At that stage, you may also be able to book optional services and book the visa appointment, for example if there is an option of a priority or speedy service for an additional fee, you may choose those options at this point.

We cannot provide specific guidance on the payment screens as it varies by country.

At this stage, you should be able to upload copies of any documents relevant to your application through the UK Visas and Immigration Commercial partner's website for free (or you can take the documents to your biometric appointment to be scanned but there will be a charge).

Note: Once you have paid for your student visa application, your application is considered as submitted. However, you will still need to attend an appointment at the Visa Application Centre to provide your biometrics.

Even if you have uploaded all of your documents for your visa application, you will still need to take your original passport to the Visa Application Centre.

Note: If you are an EU, EEA or Swiss citizen who has used the UK Immigration: ID check app, you will not normally need to attend an appointment at the Visa Application Centre or submit your passport.

20. After You Submit and Pay for your Student Visa Application

Keep a copy of your submitted application and any evidence you submitted in support of your application and save in a secure location electronically.

Save any correspondence you receive about your visa application including automated emails and confirmation emails.

Regularly check your email (inbox and junk / spam mail folders) and your mobile phone SMS messages for the contact details you have provided for any contact about your visa application.

You may be contacted about your application, to invite you to a visa interview or to request your attendance at the Visa Application Centre for another reason by email or phone.

When your visa application is decided, you will normally be notified by email along with a Visa Decision Letter.

This letter is very important as it outlines your visa details and you will need it for when you arrive in the UK, when you register / enrol at QMUL and when you go to the Post Office to collect your BRP (if you are to be issued with a BRP).

If you think you have made a mistake on your application form after you have submitted it, please contact us immediately, using the contact details at the end of this guide, so that we can advise you on the options available to you.

Some mistakes are minor and are unlikely to affect your application. However, some errors can lead to a refusal e.g. failing to declare a past refusal or an application made for a UK visa.

It may be possible to provide a cover letter to explain some errors or omissions or it may be best to withdraw or cancel the visa application and resubmit with correct information.
